Headquarters ANG Title 10 2-4 year Statutory Tour at **TEC/CC (McGhee Tyson ANGB, TN)**. Must be Air Force Specialty Code (AFSC) **Any**. Duties and responsibilities: Commands the IG Brown ANG Training & Education Center (TEC) which includes the Academy of Military Science, Enlisted Professional Military Education branch (NCOA/ALS), Instructional Development branch, TV and Multimedia branch, and the Commander's Action Group. Commands, monitors, and coordinates all Training & Education activities to insure effective management and administration of all Training & Education programs. Supervises, through a subordinate level of supervision, approximately 80 civilians and active duty personnel in the fields of academic instruction, curriculum development, and administration. Responsible for the development and justification of the annual Training and Education Center budget. Maintains continuing liaison with the host base commander. Directs the development of the education programs to be offered at the Center. Based on training needs of the ANG and current educational methodology, develops and recommends to the National Guard Bureau short- and long-range programs, goals, and objectives for the Center. Should have knowledge of personnel management systems, funding sources, budgeting, and facility/equipment maintenance. Possess a bachelor's degree, and have an extensive working knowledge of ANG structure. Highly desirable: Command experience; unit and operational experience; manpower or personnel experience in coordinating staffing issues; and working knowledge of education methodologies. Advanced education degrees and teaching experience desired.

Mandatory criteria as indicated in the MVA must be documented on the members report on individual personnel (RIP). If it is not indicated on the RIP, it is incumbent upon the applicant to ensure that the appropriate source documentation is provided with the application..

Must meet the above stated grade/rank requirement by closeout date of advertisement.

Member must have a Secret Clearance or an open investigation to apply for statutory tour positions.

Applicants who are higher grade than the highest grade for the advertisement must provide a statement of understanding with the application stating he/she is willing to be voluntarily demoted if selected for this position, IAW ANGI 36-2503, Paragraph 3.4.3

Officers applying for a statutory tour position must have a minimum of a Bachelors degree prior to applying.

Members selected for a statutory tour positions MUST provide copies of the last OPR/EPR required—units must complete any CRO or Annual reports due and forward copies to ANG/OMH prior to statutory tour orders being published. IAW AFI 36-2406, TABLE 3.1 LINE 6, NOTE 5(b)(1)(a and b).

- The report is mandatory as a result of pending separation, retirement, or PCS of the rater, or PCS or separation of the ratee, use the date 30 calendar days before the projected departure date, or:
- If the 30-day rule will cause a ratee to be ineligible for a report due to lack of supervision, adjust the close-out to the date within the 30-day window on which 120 days of supervision is achieved.
- To record significant events, the date (within the 30-day window) approved by the commander.
