The SAF CIO A6 has tasked MAJCOM A6s with additional subordinate CIO responsibilities to organize, train, and equip new Wing mission defense teams (MDTs). To meet the needs of increasing operational tempo in the face of a two major near-peer competitors, surge support is required to sustain effective and continued levels of communications and cyber support to other USAFE and AFAFRICA directorates, EUCOM, AFRICOM, NATO Allies, Partners, and the wings in both AORs. Without such temporary support, other essential and routine responsibilities will be adversely impacted as the USAFE and AFAFRICA A6 staff attempt to accomplish the additional CIO workload.
