This officer will report to Chief, A3Z and will be responsible for hosting planning sessions and advising 5th Gen specific requirements to various agencies within USAFE. Duties will focus on integration for exercises and training with all 5th Gen aircraft. Position will manage projects, taskers, actions, and programs for these events. Duties require an officer with the ability to integrate with teams from other staff directorates, contractors, SMEs, and foreign government representatives. Responsibilities include coordination of Working Groups, Operator Engagement Talks, Symposiums, or other venues as necessary to discuss 5th Gen Integration efforts. USAFE/A3Z acts as a focal point for all matters concerning 5th Gen Integration into USAFE and synchronizes efforts with other USAFE agencies. For PCS with 2-3 year commitment, command sponsorship may be available. TDYs to home unit can be authorized to maintain currency. Highly desired to already have appropriate SAP and SCI read-ins. Fighter Pilot required. Instructor/Evaluator F-35 experience is highly desired. Staff experience is preferred, but not required.
