**PERSONNEL ELIGIBLE FOR CONSIDERATION:** This position is open to current members of the Montana Air National Guard (MTANG) and those who can become a member. This is a gender neutral position. Minimum grade for this position is SrA/E-4. Applicants whose grade exceeds the Authorized Grade must be willing to voluntarily demote prior to starting AGR tour. Must have a 2WX5X AFSC to apply. This Position is available 1 Apr 21. A Secret Clearance is required for this position.

**GENERAL INFORMATION:** This position is in the Full Time Military Force (FTM) – Active Guard/Reserve (AGR) Program

**ELIGIBILITY REQUIREMENTS:** To be eligible for this position you must meet all eligibility requirements as of the closing date. Applicants must meet the eligibility requirements of ANGI 36-101 dated 3 June 2010, Chapter 5 and Attachment 2 (AGR Eligibility Checklist). **INSTRUCTIONS FOR SUBMITTING APPLICATION:**

Excess documentation will be removed. Airmen who fail to comply with these procedures will be notified. Incomplete or late application packets will not be forwarded to the Selecting Official. Application packets become the property of the MTNG and will not be returned. Application packets may be:

- a. **E-mailed** and must be in PDF format in no more than 2 attachments. Any other document format (ie TIFF, JPG, DOC, XFDL, etc) will not be processed. If you are unable to meet this requirement, contact AGR Management (listed above). Emailed applications must be received on or prior to 2359 hrs Mountain Standard Time on the closing date.

**SELECTION PROCESS:** Packages are reviewed for qualification by the MTNG HRO branch. Qualified packages are submitted to the selecting official to conduct interviews. After interviews are conducted, the Selecting Official rates applicants in order of precedence and forwards to HRO-AGR Branch. Upon approval, official notification selection/ non-selection will be made by HRO-AGR Branch.

**CONDITIONS OF ACCEPTING THIS POSITION:** Must be a member of the Montana Air National Guard (MTANG) or eligible to join the MTANG. If not a member must transfer to the MTANG before AGR orders can be started. Must be 2WX5X qualified to apply. AGR employment offer can be withdrawn. Permanent Change of Station (PCS) expenses are authorized for this position.
